with the objectives as given below:

- To establish close linkage and functional coordination between **PDUAM, Eraligool, Karimganj and Patharkandi College, Patharkandi, Karimganj.**
- PDUAM, Eraligool will collaborate in different student activities and developmental programmes with the Patharkandi College, Patharkandi from time to time.
- PDUAM, Eraligool and the Patharkandi College, Patharkandi shall undergo teacher exchange programs; so that, the human resources and teaching expertise available in the two colleges can be shared for the benefit of each of the college. Possibility of student exchange between the two colleges shall also be explored.
- PDUAM, Eraligool and Patharkandi College, Karimganj will jointly organize Seminars, Workshops, Conferences, Symposiums & Competitions from time to time. Registration shall be free for the participants of all these mutually agreed exchanges programs from the said institutes, up to a maximum of 6 persons for each of the collaborating institutes per year.



- e) Apart from the aforesaid linkage PDUAM, Eraligool and Patharkandi College, Patharkandi shall collaborate to organize extension and outreach activities like socio economic & welfare initiatives for neighboring & rural communities.
- f) Patharkandi College, Patharkandi shall help PDUAM, Eraligool to establish NCC Cell and NSS Cell in the college and jointly conduct some extension activities where the concerned cells of the two colleges shall collaborate.
- g) PDUAM, Eraligool and Patharkandi College, Patharkandi, shall jointly organize awareness campaigns, rallies, street plays etc., celebrate important occasions and appreciate good works by offering felicitation to the performers from time to time.
- h) PDUAM, Eraligool and Patharkandi College, Patharkandi shall extend support to the people in distress during any natural calamity of the region.
- i) PDUAM, Eraligool and Patharkandi College, Patharkandi shall also work in any other areas of common interest.
- j) PDUAM, Eraligool and Patharkandi College, Patharkandi shall prepare proposals for research grants from various funding agencies.
- k) Matters not covered under this MoU shall be open for incorporation from time to time subject to mutual consensus of the competent authorities of the two institutions.
- l) Either side may terminate this memorandum prior to the expiry with written notice to the other side. Any programs and/or projects in progress at the time of termination shall remain unaffected.
- m) In the event of disputes between the two institutes in connection to the MOU, the same shall be solved amicably. If the institutes are unable to do so the same shall be referred to an arbitrator to be appointed by the head of both the institutes on the basis of mutual consent. The award of the arbitration shall be final, conclusive and binding upon both parties. The intent and implementation of this memorandum is SUBJECT to the policies of the laws of the land.





